Research consultancy on masculinity and the engagement of men in sexual and reproductive health and rights.

The WHO Department of Reproductive Health and Research (RHR) seeks a Consultant to assist with its work on masculinity and the engagement of men and boys in sexual and reproductive health and rights (SRHR).

Organizational Background

The Department of Reproductive Health and Research (RHR) works towards improving sexual and reproductive health by developing guidance and tools on specific health topics, by supporting countries to implement these tools, and generating evidence on specific health topics. The Department addresses thematic areas related to vulnerability to sexual and reproductive health problems, in order to promote equitable access to services and sexual and reproductive health rights for all. These activities are in line with Sustainable Development Goal (SDG) 3, which seeks to ensure health and well-being for all and SDG Goal 5, which promotes gender equality and the empowerment of women and girls.

RHR includes the UNDP/UNFPA/UNICEF/WHO/World Bank Special Programme of Research, Development and Research Training in Human Reproduction (HRP). HRP is the main instrument within the United Nations system for promoting, conducting, evaluating and coordinating interdisciplinary research on sexual and reproductive health; for collaborating with countries in enhancing national capacities to conduct this research; for promoting and facilitating the use of research results in policy-making and planning for sexual and reproductive health care; and for the setting of standards and guidelines, including technical and ethical guidelines, in the field of sexual and reproductive health research.

The work on masculinity and engagement of men and boys in sexual and reproductive health and rights (SRHR) will be conducted in the context of the Department's work on gender equality and SRHR. The overall objectives are to systematically expand the knowledge base and fill some of the evidence gaps in the area of masculinities and SRHR.

Summary of duties:

The consultancy requires prior experience with methods for conducting systematic reviews along with a high level of analytical and communication skills.

Under the guidance of the department's focal points on gender equality, the consultant will:

- Conduct a systematic review of efforts to address masculinities in the context of SRHR programmes and interventions.
- Develop a concept note and support preparations for an expert group meeting on addressing
 masculinities in the context of sexual and reproductive health and rights including identification of topics
 on which papers will be commissioned for the meeting and of experts.
- 3. Develop policy briefs on specific issues identified; and
- 4. Other tasks related to the project as identified by the focal points.

- Previous experience conducting evidence-synthesis and familiarity with methods for conducting systematic reviews.
- Experience working on and knowledge of gender equality, masculinities in the context of SRHR issues.

- Proven communications skills and publications
- Experience working in sexual and reproductive health, ideally with experience on gender equality.

Desirable experience

Experience conducting research in low-income settings on sensitive topics;; experience working for an international organization
